## WHEN DOES YOUR COVER START?

Basic cover commences at the start of your tenancy agreement with Oxford Brookes University for personal possessions (or when your proposal is accepted, if later, for optional extensions) and expires on the 31/08/2019 or whenever your tenancy expires, whichever is sooner. You will then be responsible for arranging your own insurance cover.
